Research

My ethnographic and place-based research builds upon a unique combination of urban socio-ecological theory and historical materialism to examine built environments for barriers to health-enabling human behaviors. I focus on opportunities for spontaneous, unstructured activities for adolescents and identify inequalities between place and related physical and mental health outcomes. I contend that new opportunities for adolescents to actively engage in public space may have long-term, societal benefits.
