TEACHING

New Courses Developed:

University of Texas-Austin: J395: Covering Politics. This course introduces students to the theory and practice of political reporting, melding scholarly literature on press-state relations and journalistic norms and routines with practical reporting and writing experience, informed by a series of guest lectures by professionals in media and politics.

Louisiana State University: MC 2030/POLI 2030: Youth, Media, and Civic Engagement: This cross-disciplinary, team-taught course introduces students to a wide variety of theories and practices of civic engagement. Students consider a range of perspectives on what it means to be a "good citizen" and develop a comprehensive understanding of the ways in which contemporary young Americans engage (and do not engage) in different kinds of civic and political activities. We explore the structural, informational, and attitudinal factors that shape people's ability and willingness to engage in civic life, focusing in particular on the media (traditional and new). More broadly, we consider whether there really is a "crisis" of youth disengagement in American democracy, and critically analyze leading policy initiatives for stimulating greater youth involvement in public affairs. First offered at LSU Spring 2010.

Louisiana State University: MC 3504 Introduction to Political Communication: This course introduces students to key theories, concepts, and research findings in the field of Political Communication. In particular, it focuses on the interaction among three broad and diverse groups of players in the American system of mass-mediated politics: officials, candidates, and other elite political communicators; journalists and news organizations; and the public. We pay close attention to the dynamics of political campaigns and beyond to consider how governing happens—and how it succeeds or falters—in an increasingly mass-mediated society. First offered at LSU Fall 2009.

Louisiana State University: MC 7999: Race & Gender in Political Communication: This course explores the role of race and gender in American politics and the role of political communication in reinforcing or challenging prevailing racial and gender stereotypes and attitudes. The first segment of the course focuses on research that explores the roots of American attitudes about race and gender, providing a foundation for our discussions and student research projects. The second segment of the course zooms in on electoral politics, examining how racial/gender attitudes shape how voters vote and thus how candidates run, and how and to what degree election news is inflected with racial and gender frames. We then turn to questions of how race and gender influence policy debates, and how ethnic media matter to American politics and participation. The final weeks of the class are devoted to student presentations on current or past candidacies involving racial and/or gendered dynamics. First offered at LSU Fall 2010.

Louisiana State University: MC/POLI 4971: Film & Politics: This course examines the political nature of films. In particular, we explore how American films reflect and sometimes

challenge the enduring and evolving themes of American political culture. We approach our topic from several angles more or less at once: What is political culture, what is uniquely American about American political culture, and how are the themes and values of American political culture inscribed in many films? How do filmmakers capture and encode images in ways that tell a story and evoke (or sometimes challenge) cultural assumptions? How do we in the audience make sense of film's images and stories? How do the economics of the film industry affect the political content of films? We also explore the relationship between Hollywood and politics, and the political activism of independent filmmakers. First offered at LSU Fall of 2009.
