RULES OF EVIDENCE EXPLAINED IN SENTENCES OF TEN WORDS OR LESS, under contract with Carolina Academic Press, forthcoming in 2026

- Ten-word limit applies throughout this 175-page book, prefaced by Einstein's aphorism: "If you can't explain it simply, you don't understand it well enough"
- Written primarily for *pro se* litigants; goals are to promote access to justice and to level the playing field when laypeople must oppose attorneys in court
- Other intended audiences include students in JD and undergraduate classes, as well as mock trial competitors (at both the collegiate and high school levels)
- Covers all rules of evidence as well as related statutory and constitutional law

## **B. MEASURES OF SCHOLARLY PRODUCTIVITY AND IMPACT**

*Placements in top law journals.* I have placed my scholarship four times in top-10 journals, nine times in the top 20, and 16 times in the top 50 (based on the 2024 rankings).

*Yelnosky study of scholarly productivity.* I am the only professor at the University of Oregon whose score in the Roger Williams study of scholarly productivity exceeded the average at Harvard and Yale. This study assigned points for placements in frequently cited journals.

*Citations in court cases.* The U.S. Supreme Court cited one of my articles, and references to my scholarship have appeared in 31 briefs filed with the U.S. Supreme Court, including a brief submitted on behalf of 37 states' attorneys general. A total of 22 states' supreme courts have cited my work, as have federal appellate courts in eight circuits.

*Citations in annotated codes.* Citations to my scholarship appear in various jurisdictions' evidence codes, in the ABA's annotated Model Rules of Professional Conduct, and in Westlaw's annotated U.S. Constitution and U.S. Code.

*Overall citations.* My Hein Scholar Rank, based on academic and judicial citations, includes me in the top 10% of the 14,220 law professors counted by the U.S. Bureau of Labor Statistics.

*Presentations.* I have presented, or have recently been invited to present, at Yale, Harvard, Stanford, Columbia, NYU, Pennsylvania, Berkeley, Duke, Georgetown, UCLA, Texas, Vanderbilt, Washington University, Minnesota, Georgia, Florida, North Carolina, Alabama, Notre Dame, Boston College, Fordham, William and Mary, Davis, Washington, Utah, Indiana, SMU, and Oxford, among other schools. I have presented at conferences sponsored by the Association of American Law Schools and the American Bar Association.
